EASEMENT  
Riverton, Utah.

LEOLA F.  
MYRL LEWIS and ~~LEOLA~~ LEWIS, his wife, Grantors, of Riverton, Salt

Lake County, State of Utah, hereby give, grant, bargain and sell to  
LEON L. MITCHELL and EMMI MITCHELL, his wife, as joint tenants with the  
right of survivorship and not as tenants in common, Grantees, of  
Riverton, Salt Lake County, State of Utah, for the sum of Two Hundred  
Fifty and No/100 (\$250.00) Dollars, a perpetual easement for the mainten-  
ance of a water course and the conveyance of two (2) shares of Utah and  
Salt Lake Canal stock along the following lines and to and from the fol-  
lowing points, to-wit: -

Commencing at Weir No. 1 on the Utah and Salt  
Lake Canal, which point is in the West half of  
Section 10, Township 4 South, Range 1 West,  
Salt Lake Meridian, and running thence along the  
Easterly bank of the ~~UTAH AND SALT LAKE CANAL~~ and from  
the bank of the Canal upon and across the property  
of the Grantors along a course which the Grantors  
may designate to a point on the Westerly side of  
a State road commonly known and designated as the  
"Camp Williams Highway", which point is about 71  
feet Southwesterly from a culvert crossing said  
road and which point is described as being North  
233.24 feet and West 656.87 feet from the center  
of said Section 10; thence along the Westerly side  
of said highway to the said culvert and by means  
of the said culvert across the said highway to the  
Easterly side; thence along and parallel to the  
Easterly side of the said highway 1000 feet, more  
or less, to a County Road commonly known and desig-  
nated as 13400 South Street, according to Salt Lake  
County's numbering system. The right is reserved by  
the Grantors to designate the course of this ease-  
ment across their property so long as by means of  
the course so designated the water will flow by  
gravity to the points herein specifically described.

The terms and conditions hereof shall inure to and be binding upon  
the heirs, assigns and personal representatives of the parties hereto.
