AGENCY NOTICE OF ADOPTION OF ORDINANCE WITS BY THE OGDEN CITY COUNCIL

Pursuant to Utah Code Ann. §17C-5-109 (2016) of the Limited Purpose Local Government Entities - Community Development and Renewal Agencies Act, the Ogden City Redevelopment Agency (the "Agency") hereby provides notice that the Ogden City Council adopted Ordinance 2018-1 on January 9, 2018, adopting the Adams Community Reinvestment Project Area Plan (the "Plan"), which was also approved by the Agency on the same date, and directs that the notice of adoption be given as required by law.

The project area as described in the Plan is described as follows, to wit:

All of Blocks 2, 13, 16, 17, 26, 27, 30, 41, 44, and 55, and part of Blocks 3, 12, and 43, all part of Plat "A", all part of the Ogden City Survey; more particular described as: Beginning at the Northwest Corner of Block 12, Plat "A" and running North 01°18'08" East 1627.56 feet more or less to the southwest corner of Block 31, Plat "A", thence South 88°42'23" East 760.13 feet more or less to the southwest corner of Block 30, Plat "A", thence North 01°18'21" East 2945.89 feet more or less to the northwest corner of Block 55, Plat "A", thence South 88°42'27" East 763.58 feet more or less to the northwest corner of Block 56, Plat "A", thence South 01°18′32" West 758.92 feet more or less to the northwest corner of Block 43, Plat "A", thence South 88°41'20" East 330.91 feet more or less to the northeast corner of Lot 6, Block 43, Plat "A", thence South 01°18'19" West 663.56 feet more or less to the southeast corner of Lot 2, Block 43, Plat "A", thence North 88°42'03" West 330.86 feet more or less to the southwest corner of Lot 2.
