**Article 10.     USE AND CONDUCT RESTRICTIONS AND REQUIREMENTS.....20**

**10.4     Leases and Leasing.**

(a)     Rental Cap. In order to protect the value and desirability of the Community as a harmonious and attractive residential community and to avoid any deterioration of the same into a transient-apartment like community, leasing of Units is permissible provided however that at no time shall more than thirty-five percent (35%) of the Units in the Property be leased (there are 57 Units within the Property, therefore only 20 may be leased at a time) unless an exception in writing is granted by the Board for good cause shown. Once the maximum number of Units has been leased, Owners shall only be allowed to lease their Units as openings become available under the maximum on a first come, first served basis as logged by the Board on the Association's waiting list. This subsection shall not apply to any leasing transaction entered into by a Mortgagee which becomes the owner of a Unit through foreclosure or any other means pursuant to the satisfaction of the indebtedness secured by such Mortgage. This subsection shall apply to all subsequent purchasers therefrom.

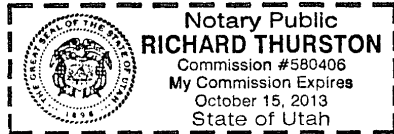
