good cause appearing therefor;

NOW, THEREFORE, it is ORDERED, ADJUDGED and DECREED that Description  
No. 3, in that certain Decree of Partial Distribution, made and entered by the above  
named court on December 11, 1973, of which a certified copy is recorded in Book  
3490, at Pages 214 to 216, of the records of the Recorder of Salt Lake County,  
State of Utah, be and it is hereby amended to read as follows:

Beginning at a point 33.0 feet West and 478.5 feet North from  
the Southeast corner of the Northeast quarter of the Northwest  
quarter of Section 15, Township 3 South, Range 1 West, Salt Lake  
Base and Meridian, and running thence North along the West line of  
Redwood Road 468.4 feet; thence West 179.0 feet, more or less;  
thence Southerly along a curve to the right having a radius of  
1877.08 feet to a point which is South 118.9 feet and West 144.7  
feet from the point of beginning; thence West 70.0 feet; thence  
Southerly 33.0 feet East of the center line of the Utah and Salt  
Lake Canal, a distance of 357.0 feet, more or less, to the North  
boundary line of an East and West County Road; thence East along  
said North boundary line 219.0 feet, more or less, to a point  
33.0 feet North and 83.0 feet West of the said Southeast corner  
of the Northeast quarter of the Northwest quarter of Section 15;  
thence North 200.0 feet; thence West 24.0 feet, more or less;  
thence Northerly along a curve to the left having a radius of  
1947.08 feet, which was the former right of way of the Salt Lake  
& Utah Railroad; thence East 50.0 feet to the point of beginning.
