FINAL AMENDMENT TO SECTION 2 OF REDEVELOPMENT PLAN FOR PROJECT AREA NO. ONE

The Redevelopment Plan for Redevelopment Project No. One, Section 2, "Project Area Boundaries", is hereby amended to reduce the amount of property in the Project Area to approximately 39.11 acres.

That portion of the Project Area that was included in the 100 acre limit of privately owned property on July 26th, 1983 by Resolution No. 164 is reduced to approximately 19.5 acres. The general description of this portion of the Project Area is:

This Amendment shall not be substituted for the previous Redevelopment Plan and establishment of the Redevelopment Project Area No. One, but will only reduce the project area boundary to approximately 39.11 acres. The date of adoption of the original Redevelopment Project No. One Plan shall continue to be the effective date of the Redevelopment Plan for Project Area No. One, and the effective date of this Amendment shall in no way modify or alter the effective date of that previously adopted plan.
