Grantee, the receipt whereof is hereby acknowledged, hereby grants, bargains and conveys unto The Mountain States Telephone and Telegraph Company, a Colorado corporation, 931 14th Street, Denver, Colorado, 80202, Grantee, its successors, assigns, lessees, licensees and agents, a Right-of-Way Easement and the right to construct, operate, maintain and remove such communication and other facilities, from time to time, as said Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to-wit:

FIVE foot easement over the of the Grantors property, the specific description to be filled in at a later time.

A five foot easement being 2 1/2 feet on each side of buried telephone facilities as shown on Exhibit "A" attached hereto and made a part hereof across the following described property:

A part of the Northwest Quarter of Section 12, Township 5 North, Range 2 West, Salt Lake Base and Meridian, U.S. Survey: Beginning at the intersection of the East line of 1900 West Street and the South line of 4000 South Street said point being 47.41 feet North 89°41'15" East along the centerline of 4000 South Street and 33.00 feet South 0°33' West from the Northwest corner of said Section, running thence North 89°41'15" East 1081.11 feet along the South line of said street, thence South 0°33' West 125.00 feet, thence South 44°32'34" West 137.80 feet, thence South 89°41'15" **

situate in County of CLATSOP State of OREGON

TOGETHER with the right of ingress and egress over and across the lands of the Grantor to and from the above-described property, the right to clear and keep cleared all trees and other obstructions as may be necessary and the right to permit other utility companies to use the right of way jointly with Grantee for their utility purposes.

The Grantor reserves the right to occupy, use, and cultivate said property for all purposes not inconsistent with the rights herein granted.
