KNOW ALL MEN BY THESE PRESENTS:

That Frank McCarthy, Agent, of Salt Lake City, Utah, in consideration of the sum of One Dollar and other valuable considerations, to him in hand paid by the Uinta Pipe Line Company, a Delaware corporation, authorized to transact business in the State of Utah, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, assign, transfer and convey unto the said Uinta Pipe Line Company, its successors and assigns, all of his right, title and interest in and to certain lands in Summit County, Utah, as grantee in and under certain right of way grants for pipe line and telephone or telegraph line purposes, which said right of way grants and the lands covered and affected thereby are described as follows, to-wit:
