Wilde and Vernal Rex Crittenden an unmarried man, of Hoytsville, Summit County, Utah, Grantors, do hereby for themselves their heirs, executors, administrators, successors and assigns grant and release to Mountain Fuel Supply Company, a corporation organized and existing under and by virtue of the laws of the State of Utah, its successors and assigns, the right of way to lay, maintain, operate, inspect, repair and remove pipe lines, and to erect, maintain, operate, inspect, repair and remove telegraph and telephone lines, together with such stations, meter houses and other facilities and structures as may be necessary or convenient for the operation, maintenance, inspection, protection and repair of said lines over and through lands in Township 2 North, Range 5 East, S.L.M., County of Summit, State of Utah, bounded and described as follows:

including the waiver and release of the right of homestead, with the right of ingress and egress to and from the same.

Should more than one pipe line be laid under this grant at any time, a like consideration will be paid for each line so laid in addition to the damages above provided for

## RIGHT OF WAY GRANT

FOR AND IN CONSIDERATION of Ten Dollars, in hand paid, the receipt whereof is hereby acknowledged Heber Sargent, widower, of Hoytsville, Summit County, Utah, does hereby for himself his heirs, executors, administrators, successors and assigns grant and release to Mountain Fuel Supply Company, a corporation organized and existing under and by virtue of the laws of the State of Utah, its successors and assigns, the right of way to lay, maintain, operate, inspect, repair and remove pipe line, and to erect, maintain, operate, inspect, repair and remove telegraph and telephone line over and through lands in Township 2 North, Range 5 East, S.L.M. County of Summit, State of Utah, bounded and described as follows:

Part of the SW $\frac{1}{4}$ SW $\frac{1}{4}$  Section 22) The 20" pipe line to be laid parallel to and  
Part of the NW $\frac{1}{4}$ NW $\frac{1}{4}$  Section 27,) approximately nine (9) feet easterly  
Part of the E $\frac{1}{2}$ NE $\frac{1}{4}$  Section 28,) from the present 16" Pipe Line.

The right of way to extend easterly 50 feet and westerly 20 feet from the 20" pipe line.

including the waiver and release of the right of homestead, with the right of ingress and egress to and from the same as described below. The aforesaid Heber Sargent to fully use and enjoy the said premises except for the purposes hereinbefore granted to the said Mountain Fuel Supply Company, which hereby agrees to pay any damages which may arise to the crops, or fences or irrigation system from the laying, erecting, maintaining, operating, inspecting or removing of said pipe, telegraph and telephone line. Said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one of whom to be appointed by the said Mountain Fuel Supply Company, its successor or assigns, one by the said Heber Sargent, his heirs, legal representatives, successor or assigns, and the third by the two so appointed as aforesaid, and the award of such three persons or any two of them shall be final and conclusive. All fences are to be left in good repair satisfactory to Grantor. Ingress and egress to and from this right-of-way is limited to the above right of way width and from the place where the right-of-way enters and leaves the Grantor's land and from the road up Spring Canyon.
