ACCESS CONTROL ADMINISTRATIVE DETERMINATION AMENDMENT SR-68 – UTAH COUNTY

The Utah Department of Transportation wishes to create one (1), sixty two foot (62') break in the existing Easterly Limited-Access Line to facilitate the construction, maintenance and access to/from a proposed Lehi City road, said access opening is located approximately 1152.07 ft., N. 89°48'52" E. along the north line of the SW1/4 and 1282.59 ft., S. 00°11'08" W. from the West Quarter Corner of Section 2, T. 5 S., R. 1 W., S.L.B. & M.

The Utah Department of Transportation, having rights of jurisdiction over highways in the State of Utah per Utah State Code § 72-1-201 and Utah State Code § 72-3-102 as amended, breaks the existing easterly right-of-way and Limited-Access Line of SR-68 for the safety and welfare of the travelling public and to benefit the welfare of the State of Utah, said opening opposite Highway Engineer Station 213+27.46 and 213+42.55 from the control line of 2100 North Street Project No. MP-R399(41), said opening in the Easterly Limited Access Line of SR-68 also being opposite approximate Highway Engineer Stations 688+51.01 and 689+16.86 from the control line of Project No. F-0068(45)33 and shown on UDOT Project No. MP-R399(41) right of way plan sheet 7A and UDOT Project No. F-0068(45)33 right of way plan sheet 26.

Note: Access opening is located at approximate Highway Engineer Station 688+85.47 from the control line of Project No. F-0068(45)33 and is subject to the relinquishment of the 32 foot commercial access opening at approximate Highway Engineer Station 691+49.51.
