10 WHEREAS, the Municipal Council of Provo, Utah finds after public hearing the
11 Provo City Landmarks Commission has completed a review of the Neils Johnson/Ray
12 Hansen House to determine whether said property meets the "Criteria for Designating
13 Historic Property in the Provo Landmarks Register"; and,

15 WHEREAS, the Municipal Council of Provo, Utah finds after public hearing the
16 Provo City Landmarks Commission has reviewed said property and has determined it meets
17 all the "Criteria for Designating Historic Property in the Provo Landmarks Register"; and,

19 WHEREAS, the Municipal Council of Provo, Utah finds after public hearing it is in
20 the interest of the public's health, safety, morals and general welfare to designate said
21 property as an official landmark on the Provo City landmark register;

23 NOW THEREFORE, be it resolved by the Municipal Council of Provo City, Utah,

28 1. The Neils Johnson/Ray Hansen House, as more fully described in the attached
29 exhibit, is hereby approved to be designated on the Official Provo City Landmarks Register
30 as a Historical Landmark.

33 shall record said designation with the Utah County Recorder's Office.
