WHEREAS, the Municipal Council of Provo, Utah finds after public hearing the Provo City Landmarks Commission has completed a review of the Neils Johnson/Ray Hansen House to determine whether said property meets the "Criteria for Designating Historic Property in the Provo Landmarks Register"; and,

WHEREAS, the Municipal Council of Provo, Utah finds after public hearing the Provo City Landmarks Commission has reviewed said property and has determined it meets all the "Criteria for Designating Historic Property in the Provo Landmarks Register"; and,

WHEREAS, the Municipal Council of Provo, Utah finds after public hearing it is in the interest of the public's health, safety, morals and general welfare to designate said property as an official landmark on the Provo City landmark register;

NOW THEREFORE, be it resolved by the Municipal Council of Provo City, Utah, as follows:

PART I:

- 1. The Neils Johnson/Ray Hansen House, as more fully described in the attached exhibit, is hereby approved to be designated on the Official Provo City Landmarks Register as a Historical Landmark.
- 2. The Landmarks Commission shall promptly notify the owners of this action and shall record said designation with the Utah County Recorder's Office.
