POLE LINE EASEMENT

Boggess, his wife, Grantor, hereby convey and warrant to Telluride Power Company, a corporation, its successors and assigns, Grantee, for the sum of One Dollar and other valuable consideration, the receipt whereof is hereby acknowledged, an easement and right-of-way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits of the Grantee, and (1) One guy anchors and (1) One pole or towers, with the necessary attachments thereon or affixed thereto, for the support and protection of said circuits, together with the right to remove trees and other obstructions which may interfere with Grantee's use and occupation of this easement, and such rights of ingress and egress as are reasonably necessary for the erection and maintenance of said circuits, over, upon, and across the premises of Grantor, in Sevier County, Utah, along a line described as follows:

Commencing at a point on Grantor's land 1896 ft. West and 1930 ft. North more or less from South East corner of Section 24, Township 23 South, Range 3 West, S.L.M. Thence, running west 210 Ft.
