Miller, LLC, a Limited Liability Company of the State of Utah Grantor, hereby GRANTS AND CONVEYS to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum of \_\_\_\_\_ Dollars, a permanent easement, upon part of Lots 6 and 7 of the Amended Plat of Copper Springs 3, Commercial Park, situate in the NW $\frac{1}{4}$  SE $\frac{1}{4}$  and SW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 32, T.12N, R.1E, SLB&M, in Cache County, Utah, for the purpose of facilitating the relocation of public utilities and construction of cut and/or fill slopes and appurtenant parts thereof incident to the widening of the existing State Highway SR-252 known as Project No. S-0252(6)0.

The boundaries of said part of an entire tract are described as follows:

Beginning on the east right of way line of State Highway SR-252 at a point 52.5 feet perpendicularly distant easterly from the control line of said Project at Engineer Station 245+12.7, said point of beginning being approximately 2.59 feet East of the Northwest Corner of said Lot 7, Amended Plat of Copper Springs 3, Commercial Park; running thence along said east right of way line the following four (4) courses; 1) S. 1°23'21" W. a distance of 69.35 feet; 2) Southerly 60.61 feet along the arc of a 6552.50-foot radius curve to the right (Note: Chord bears S. 1°39'15" W. for a distance of 60.61 feet); 3) S. 1°55'09" W. a distance of 159.70 feet; 4) S. 43°46'24" E. a distance of 20.96 feet; thence N. 1°55'09" E. a distance of 174.34 feet; thence Northerly 60.75 feet along the arc of a 6567.50-foot radius curve to the left (Note: Chord bears N. 1°39'15" E. for a distance of 60.45 feet); thence N. 1°23'21" E. a distance of 69.35 feet to the north boundary of said subdivision, thence N. 88°36'39" W. a distance of 15.00 feet to the point of beginning as shown on the official plans for said project on file in the office of the Utah Department of Transportation

The above described part of an entire tract contains 4456 sq. ft. of which 1896 sq. ft. is already a existing Public Utility Easement as shown on said subdivision plat. Net area totals 2560 sq. ft. or 0.059 acre.


