Parcel 1 & Lot 3, New Vista Subdivision Plat "C" Sewer Easement Description

A sewer line easement being a strip of land 20.00 – feet in width being a part of Parcel 1 and Lot 3, New Vista Subdivision Plat "C" recorded August 6, 2020 as Entry No. 115098:2020 having Map No. 17198 in the Office of the Utah County Recorder and located in the East Half of Section 20, Township 7 South, Range 3 East, Salt Lake Base and Meridian. Said 20.00-foot wide strip of land lies 10.00 - feet on each side of the following described centerline:

Beginning at a point on the easterly line of said Lot 3, which is 1814.79 feet N. 89°35'40" E. along the Section line and 3340.29 feet South from the North Quarter of said Section 20, said point also being 15.49 feet N. 29°28'41" W. from a southeasterly corner of said Lot 3; thence N. 74°22'50" W. 221.14 feet; thence N. 22°07'23" W. 1546.24 feet; thence N. 20°44'32" E. 199.02 feet to the easterly line of said Parcel 1 and the **Point of Terminus**.

The sidelines of said 20.00 wide strip of land shall be lengthened or shortened to begin on said easterly line of said Lot 3 and terminate on the easterly line of said Parcel 1.

The above-described sewer line easement contains 39,328 sq. ft. in area or 0.902 acre, more or less.
