EASEMENT (CORPORATION)

Lagoon Company, formerly Simon Bamberger Company, Grantor hereby grant and convey to State Road Commission of Utah, Grantee, for the sum of Eleven and 20/100 DOLLARS, an easement over the following described premises situated upon the grantor land in the SE $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 35, T. 1S., R. 4 E., S. L. M. in Summit County, Utah, for the purpose of constructing thereon a channel change for Silver Creek and appurtenant parts thereof:

A parcel of land 70 feet wide, 35 feet on each side of the following described center line insofar as said parcel lies within said Section 35.

Beginning at a point on the northerly no access line of highway known as Project No. F-234, said point being directly opposite Engineer's Station 757+61.4 on the center line of survey of said project, said point also being approximately 883 feet west and approximately 251 feet north from the SE corner of said Section 35; thence N. 26°44' E. 13.0 feet to a point of tangency with a 40 foot radius curve to the right; thence Northeasterly 31.8 feet along the arc of said 40 foot radius curve; thence N. 71°44' E. 190 feet, more or less, to the center line of the existing channel.

ALSO:

Beginning at a point on the southerly no access line of said project opposite Engineer's Station 757+61.4 on said highway center line, which point is approximately 973 feet west and approximately 73 feet north from the SE corner of said Section 35; thence S. 26°44' W. 67.7 feet to a point of tangency with a 40 foot radius curve to the right; thence Westerly 46.8 feet along the arc of said 40 foot radius curve; thence N. 66°15' W. 6 feet, more or less to the easterly right of way line of the Park City Branch of the Union Pacific Railroad Company.

The above described parcels of land contain 0.56 acre, more or less.
