NOTICE OF REINVESTMENT FEE COVENANT

(The Lochs at Water's Edge Subdivision, Vineyard, Utah County, State of Utah)

Pursuant to Utah Code Ann. \$57-1-46(6) notice is hereby given that each Unit within that parcel of real property located in Vineyard, Utah, and more particularly described on **Exhibit A** hereto ("**Property**") is subject to a covenant obligating a future buyer or seller of any Unit within the Property to pay to the The Lochs at Water's Edge Owners' Association ("**Association**"), upon and as a result of a transfer of a Unit within the Property, a fee that is dedicated to benefitting such Unit ("**Reinvestment Fee**").

- 1. The Property is subject to that certain Declaration of Covenants, Conditions and Restrictions for The Lochs at Water's Edge Owners' Association ("Declaration"), recorded with the Utah County Recorder's office on NOV 3, as Entry No. 110010.
