

**NOTICE TO SELLERS, BUYERS AND TITLE COMPANIES  
OF FEE OBLIGATION DUE ON PURCHASE**

WESTGATE TOWNHOME OWNERS ASSOCIATION, a Utah non-profit corporation (the "Association"), hereby gives notice that pursuant to Section 8.06 of that certain Declaration of Easements, Covenants, Conditions and Restrictions, Westgate Townhomes, A Planned Unit Development (Expandable), Provo, Utah County, Utah, dated August 12, 1992, filed for record on August 19, 1992, as Entry No. 42191, Book 2984, Page 765, Office of the County Recorder of Utah County, State of Utah, an initial purchase fee in an amount equal to the then monthly installment of the annual assessment is required to be paid to the Association upon purchase of any Unit within the Westgate Townhomes project. Such fee shall be in addition to any proration of the monthly installment of such annual assessment that is due during the month of purchase. The seller, buyer or title company involved in the transaction should contact the Treasurer of the Association with the name and mailing address of the purchaser and the title company should collect the appropriate fee for the Association from escrow at the close of the transaction; otherwise the Association will file a lien to enforce collection.

The property subject to the fee obligation referred to herein is described as follows:


