EDDIE WILLIAM ERNST, a single man, Grantor, of Salt Lake County, Utah, hereby grants and conveys to SALT LAKE CITY CORPORATION, a municipal corporation of the State of Utah, Grantee, in consideration of the sum of Ten and 00/100 (\$10.00) Dollars, and other good and valuable consideration, receipt of which is hereby acknowledged, a perpetual easement and right of way for the construction, repair, improvement and maintenance of a canal and banks for conducting and flowing sewage waste and water and sewage effluent from sewage treatment plant therein and such drainage water as may naturally come to and flow from said canal over, along, across a tract of land one hundred (100) feet in width, situated in Salt Lake County, State of Utah and located in Sections 9 and 10, T 1 N, R 1 W, S.L.B. & M., the center line of which is particularly described as follows:

Commencing at a point south 1215.23 feet and west 403.89 feet, from the Northeast corner of Section 9, T 1 N, R 1 W, S.L.B. & M., and running thence South 36°52'34" East, 1211.71 feet; thence South 42°20' East, 229.56 feet; thence South 22°16'10" East, 100.03 feet; thence South 6°33'10" East, 103.31 feet; thence South 8°10' West, 138.53 feet; thence South 29°17'41" West, 399.34 feet to the south property line of the Ed Ernst property. Also commencing at a point south 2549.42 feet and East 527.54 feet from the Northeast corner of Section 9, T 1 N, R 1 W, S.L.B. & M., and running thence South 49°30' East, 163.50 feet; thence South 68°30' East, 150.10 feet; thence South 75°20' East, 289.20 feet; thence South 78°51' East, 229.40 feet to the East property line of the Ed Ernst property, said point also being the west bank of the Jordan River;

together with the right of ingress to and egress from and over and along said tract for all purposes for the full enjoyment of said right of way and easement.

Grantee shall have the right to place upon said right of way such spoils and materials as Grantee, from time to time, may deem necessary to take from said canal and its banks along said right of way to properly clean and maintain said canal.
