POLE LINE EASEMENT

Peter C. Marcusen and Lillie Marcusen

his wife, Grantor.s, of Cache County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and no guy anchors and one poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor.s, in Cache County, Utah, along a line described as follows:

Beginning at a fence on the north boundary line of the Grantors' land at a point 339 feet south and 210 feet east, more or less, from the northwest corner of Lot 4, Block 1, Plat "D", Logan Farm Survey, thence S. 1° 11' W. 313 feet, more or less, to the south boundary line of said land and being in said Lot 4, the NW 1/4 of Section 27, T. 12 N., R. 1 E., S.L.M.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
