WHEREAS First Party on March 3, 1958 executed certain Protective

Convenants and Restrictions in respect to IAKTWOOD SUBDIVISION NO. 3 which Protective Convenants were recorded on the 3rd day of March, 1958 in Book 1486 and Page 398.

WHEREAS all parties to this Agreement desire to amend said Protective Convenants in one respect;

NOW, THEREFORE, in consideration of the mutual Covenants and Agreements contained herein it is mutually agreed among all of the parties hereto that those certain restrictions calling for a minimum of 1500 Sq_{\bullet} Feet in the case of one story single family dwellings and a minimum of 1,000 Sq. Feet in the case of one and a half or two story single family structures is hereby amended to provide for a minimum of 1200 Sq. Feet in the case of one story single family dwellings and not less than 900 Sq. Feet in the case of one and a half or two story single family structures for Lots 301 and 302 only. All other terms and conditions of said Protective Covenants to remain in full force and effect.
