

AFFIDAVIT OF RIGHT-OF-WAY AND EASEMENT CENTERLINE DESCRIPTION

Kern River Gas Transmission Company, a Texas general partnership, whose address is P. O. Box 58900, Salt Lake City, Utah 84158-0900, hereinafter referred to as "Affiant", is the Grantee of a Right-Of-Way and Easement Agreement identified as follows:

Grantor: Eugene L. Kimball and Ruth M. Kimball, husband and wife.  
Dated: March 20, 1990, recorded as Entry Number 10144, in Book 2678, Page 340, Utah County, Utah.

Whereas, Kern River Gas Transmission Company obtained an as-built survey of the permanent pipeline right-of-way and easement after construction. Now therefore, for and in consideration of the mutual covenants, promises and agreements contained in said Right-Of-Way and Easement Agreement, Kern River Gas Transmission Company does hereby specify the width and location of such right-of-way and easement as follows: to wit:

As-Built Description

A 50 foot permanent easement across a portion of the North half of the Northeast quarter and part of the Northeast quarter of the Northwest quarter of Section 7, Township 6 South, Range 1 West, Salt Lake Base and Meridian, Utah County, Utah, being 25 feet each side of and parallel to the following described centerline of an existing 36 inch diameter pipeline (sidelines to be shortened or lengthened to terminate at the parcel line):

Commencing at a point located on the North line of Section 7, Township 6 South, Range 1 West, Salt Lake Base and Meridian said point being North 89° 25' 33" West (Bearings are based on Utah State plane coordinate system - central zone - 1927 data), 2590.9 feet from the Northeast corner of said section 7 and running

Thence South 03° 13' 10" West 1363.3 feet, more or less,

To a point on the South property line and the terminus of said centerline thence North 63° 24' 35" East 2982.0 feet to the point of commencement.

The centerline being 1363.3 feet, containing 1.6 acres more or less.

Affiant states that the description of the hereinabove right-of-way and easement is the surveyed centerline description, and that the description has been recorded.
