FIRST AMENDMENT TO DECLARATION OF EASEMENTS, COVENANTS, CONDITIONS AND RESTRICTIONS

PARK RIDGE

An Expandable Planned Unit Development

Provo, Utah County, Utah

THIS FIRST AMENDMENT to Declaration of Easements, Covenants, Conditions and Restrictions (the "First Amendment") is made as of the 19th day of December, 2000, by the consent of Lot Owners in Park Ridge Expandable Planned Unit Development, Provo, Utah (the "Development") who collectively hold at least sixty percent (60%) of the total outstanding votes in the Park Ridge Owners Association, a Utah nonprofit corporation (the "Association").

RECITALS

- A. All defined terms as used in this First Amendment shall have the same meanings as those set forth and defined in that certain **Declaration of Easements**, **Covenants**, **Conditions and Restrictions**, **Park Ridge**, **An Expandable Planned Unit Development**, recorded as Entry 58606, Book 4336, Pages 276-301, inclusive, in the Office of the Utah County Recorder on August 4, 1997, as the same may have been supplemented or amended by any Supplement to Declaration or Amended Supplement to Declaration following such date (together the "Declaration").
- B. The Declaration requires amendment to include 15 additional residential Lots and Units within the Development on real property already described in the Declaration as Additional Land for expansion purposes but which was originally intended to be used for commercial buildings, which commercial use is to be abandoned upon approval and recordation of this First Amendment.
- C. In addition to authorizing the additional Lots and Units as set forth in Recital B, above, this First Amendment authorizes any future amendments to the Declaration to be made by the Association upon the certification of its signatory officers that the required vote or consent of Owners was obtained and is so recorded in the books and records of the Association, thus avoiding the cumbersome process of obtaining, notarizing and recording numerous Owners' signatures as apposed to only those of the Association's certifying signatory officers.

THEREFORE, by written consent of the following Owners who comprise in the aggregate in excess of sixty percent (60%) of the total outstanding votes of the Association, as required by Sections 14.02 and 14.03 of the Declaration, the Declaration is hereby amended in the following particulars:

- 1. Sub-Section 3.04(b) of the Declaration is amended in its entirety to read as follows:
- (b) Declarant shall not effectuate any annexation of land which would cause the total number of Lots existing in the Development to exceed one-hundred twenty-eight (128).
- 2. Section 14.02 of the Declaration is amended in its entirety to read as follows:
- 14.02 Amendment. The vote of Owners (including Declarant) who collectively hold at least sixty percent (60%) of the total outstanding votes in the Association shall be required to amend this Declaration (including the Association Bylaws set forth herein). Any amendment so authorized shall be accomplished through the recordation of an instrument executed by the Association's President or Vice President and Secretary or Assistant Secretary wherein they certify that the vote required for amendment has occurred and that a written record thereof exists in the Association records. In addition, such right of amendment shall be subject to the following qualification: no amendment to any provision of this Declaration which has the effect of diminishing or impairing any right, power, authority, privilege, protection, or control accorded to Declarant (in its capacity as Declarant), or to a Mortgagee or to the Association shall be accomplished or effective unless the instrument through which such amendment is purported to be accomplished is consented to in writing by Declarant, the Association or by such Mortgagee, as the case may be.

Except as amended by this First Amendment, the Declaration shall remain unchanged and, together with this First Amendment, shall constitute the Declaration of Easements, Covenants, Conditions and Restrictions for the Development.


