ABANDONMENT OF EASEMENT

For valuable consideration, the receipt of which is hereby acknowledged, **Granger-Hunter Improvement District** a body politic of Salt Lake County, State of Utah organized and existing under the laws of the State of Utah with its principal office at 2888 South 3600 West, West Valley City, County of Salt Lake, State of Utah, hereby abandon the following described portion of Granger Hunter Improvement District easement for the Decker North Sewer Lift Station:

BEGINNING at a point on the west Line of 2300 West Street, said point lying South 89°55'24" West 530.92 feet North 5°48' East 39.98 feet, North 84° 12' West 33.00 feet to the west line of said street, South 5°48' West along, said west line 814.87 feet, South along said west line 664.94 feet to the point of curvature of a 233.00 foot radius curve to the left, and South 33.50 feet from the East Quarter corner of Section 21, Township 1 South, Range 1 West, Salt Lake Base and Meridian and running thence West 20.00 feet; thence South 40.00 feet; thence East 31.90 feet to a point on the west line of 2300 West Street, said point being on a 233.00 foot radius curve to the right from which the radius point bears North 71°36'43" East; thence Northerly along said curve and said west line 41.16 feet; thence West. 2.42 feet to the POINT OF BEGINNING.

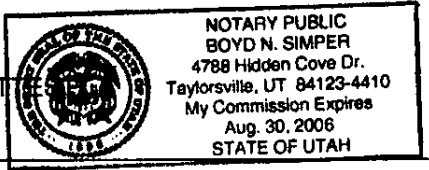
