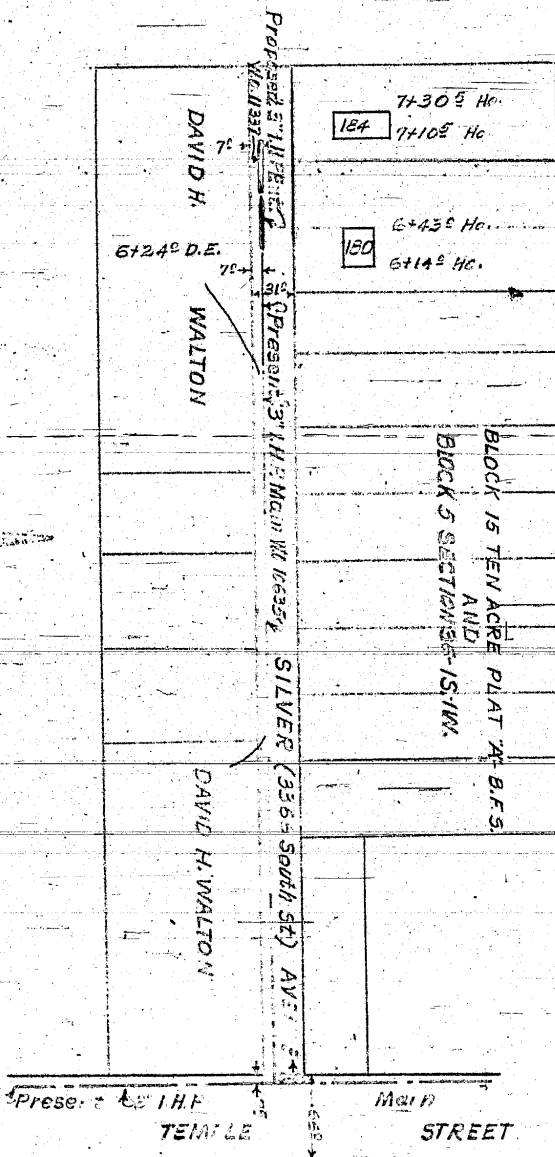
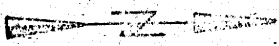

 assigns or grantees, because of the construction, maintenance or operation of said pipe line.

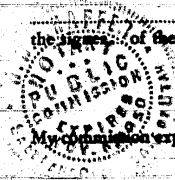
