Four Hundred (\$400.00) and no/100----- Dollars, a perpetual right-of-way

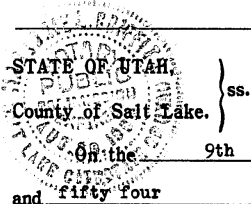
over and across the following described tract of land in Salt Lake County, State of Utah:
