Right-Of-Way Deed

Utah Power & Light Company, a corporation of the State of Maine, doing business in the State of Utah, and Utah Light And Traction Company, a corporation of the State of Utah, grantors, hereby quit-claim to Salt Lake County, grantee, for the sum of One (\$1.00) Dollar, a perpetual right-of-way over and across the following described tract of land in Salt Lake County, State of Utah:

A strip of land 40 feet wide, being 20 feet wide on each side of the center line of right-of-way, said center line of right-of-way being more particularly described as follows:

Beginning at the north line of grantors' property 457.9 feet west of the northeast corner of the northwest quarter of Sec. 25 of Twp. 2 S. R. 1 E of the S. L. B. & M., and running thence S. 47 degrees, 17' E, parallel to, and 25 feet northeast from a pole line as now constructed, 1522.6 feet; thence S. 63 degrees 7' E. 265. feet; thence S. 17 degrees 42' E. 157.5 feet; thence S. 89 degrees 12' E. 397.1 feet; thence S. 59 degrees 2' E. 107.4 feet; thence S. 70 degrees 37' E. 106. feet; thence S. 78 degrees 56' E. 111.7 feet; thence S. 25 degrees 41' E. 121. feet; thence S. 34 degrees 32' E. 384.6 feet; thence S. 85 degrees 35' W. 90.7 feet; thence No. 70 degrees 02' W 161.5 feet; thence S. 76 degrees 46' W 107. feet to the intersection of the main road and end of line; containing 3.25 acres.

It is the intention of grantors to donate said right-of-way to said Salt Lake County for the use of the public as a highway, subject, however, to the terms of a mortgage given by the Utah Light and Traction Company to the Bather's Trust Company of New York as trustee, under date of September, 19th, 1914; and to the terms of a mortgage given by the Utah Power & Light
