ABSTRACT OF DECISION

I, Rae Atkinson, being first duly sworn, depose and say that I am the Coordinator of the Salt Lake County Board of Adjustment, and that on June 18, 2003, Application #20962, submitted by Wasatch Pacific Inc., was heard by the Board. By motion seconded and carried, the Board of Adjustment approved the request for a variance from section 19.72.030 D.3.b. Streets/Roads and General Site Access to construct a road that will cross slopes between thirty percent and fifty percent for a length of nearly 1,000 feet; a variance from section 19.72.030 D.3.c. Streets/Roads and General Site Access to construct a road that will cross slopes between thirty percent and fifty percent for 40.5%; a variance from section 19.72.030 D.3.c Streets/Roads and General Site Access to construct a road crossing slopes greater than 50% percent for 385 feet, or 15% of the total length of the road at 3931 East Big Cottonwood Canyon Road in an F-1 zone. The variance was granted subject to the following conditions:

- 1. Compliance with all ordinance requirements for which variances or exceptions have not been granted by the time of final roadway design, and all agency recommendations and conditions of approval imposed on the final design and development of the proposed roadway through the permitted use process.
- 2. Work with staff to develop a long term reserve fund and maintenance plan..
