ORDINANCE NO. 92-24

AN ORDINANCE REPEALING ORDINANCE NO. 227 ADOPTED OCTOBER 7, 1980 WHICH ORDINANCE ESTABLISHED A NEIGHBORHOOD DEVELOPMENT PROGRAM AND DESIGNATED THE CITY COUNCIL AS THE REDEVELOPMENT AGENCY FOR KAYSVILLE CITY; REPEALING ORDINANCE NO. 242 ADOPTED DECEMBER 15, 1981 FOR THE PURPOSE OF ADOPTING THE REDEVELOPMENT PLAN FOR THE KAYSVILLE DOWNTOWN REDEVELOPMENT PROJECT AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Kaysville City adopted Ordinance No. 227 on October 7, 1980 under the "Utah Neighborhood Development Act" and designated the Kaysville City Council as the Kaysville Redevelopment Agency for Kaysville City; and,

WHEREAS, Kaysville City adopted Ordinance No. 242 on December 15, 1981 for the purpose of adopting the Redevelopment Plan for the Kaysville Downtown Redevelopment Project; and,

WHEREAS, Kaysville City now desires to dissolve the Kaysville Redevelopment Agency and terminate all programs now pending under its auspices; and,

WHEREAS, all necessary documents and conveyances have been signed and delivered between Kaysville City and the Kaysville Redevelopment Agency to transfer and convey all of the Kaysville Redevelopment Agency real property, personal property, choses in action and other assets from the Kaysville Redevelopment Agency to Kaysville City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF KAYSVILLE CITY, STATE OF UTAH, as follows:

SECTION ONE

GENERAL FINDINGS

Kaysville City created the Kaysville Redevelopment Agency by adopting Ordinance No. 227 on October 7, 1980. Kaysville City created a Redevelopment Plan for the Kaysville Downtown Redevelopment Project by adopting Ordinance No. 242 on December 15, 1981. The City Council now finds and determines that it is not presently necessary or desirable to continue to have a Redevelopment Agency in the City nor is it necessary or desirable to continue with the Kaysville Downtown Redevelopment Project.

The Kaysville Redevelopment Agency and Kaysville City have both taken all action requisite and necessary to wind up the affairs of the Kaysville Redevelopment Agency.

SECTION TWO

REPEAL OF ORDINANCE NO. 227

Ordinance No. 227 entitled "An Ordinance Establishing a Neighborhood Development Program Pursuant to the Provisions of Utah State Law, Designating the City Council as the Redevelopment Agency for Kaysville City; Setting Forth Powers and Duties of the Redevelopment Agency and Providing for the Adoption of Redevelopment Plans; the Implementation of Projects by Application for Federal Funds and Giving Notice "hereof" adopted October 7, 1980 is hereby repealed.

SECTION THREE

REPEAL OF ORDINANCE NO. 242

Ordinance No. 242 entitled "An Ordinance Adopting the Redevelopment Plan for the Kaysville Downtown Redevelopment Project (as modified by the Kaysville Redevelopment Agency on December 15, 1981) as the Official Redevelopment Plan for the Kaysville Downtown Redevelopment Project Area" adopted December 15, 1991 is hereby repealed.

SECTION FOUR

INTENT OF ORDINANCE

It is the intent of this Ordinance to complete the winding up of the affairs of the Kaysville Redevelopment Agency and to dissolve the Kaysville Redevelopment Agency completely. To the extent that there is any right, title or interest in and to any real or personal property or choses in action which have not heretofore been transferred and conveyed by the Kaysville Redevelopment Agency to Kaysville City, any and all such rights, titles and interests, if any, are hereby declared to be in the name of Kaysville City as successor in interest of the Kaysville Redevelopment Agency.

SECTION FIVE

EFFECTIVE DATE

This Ordinance shall become effective immediately following passage and adoption and publication of a summary of this Ordinance as required by law.

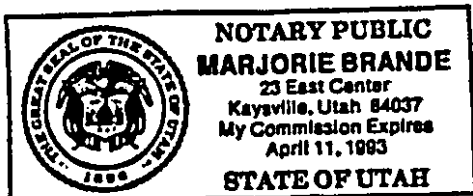
