## FIRST AMENDMENT TO THE SECOND AMENDED AND RESTATED TRACT DECLARATION FOR SKYLINE AT TOWNE CENTER PHASE II

This First Amendment to the Second Amended and Restated Tract Declaration for Skyline at Towne Center Phase II (the "First Amendment") is executed and adopted by HTC Towns, LLC, a Utah limited liability company ("Declarant").

## **RECITALS**

- A. The Second Amended and Restated Tract Declaration for Skyline at Towne Center Phase II was recorded in the office of the Salt Lake County Recorder on August 16, 2018 as Entry No. 12830459, Book 10703, and Pages 4879-4940 (hereinafter the "Declaration").
- B. This First Amendment affects the real property located in Salt Lake County, described with particularity on Exhibit A, which exhibit is attached hereto and incorporated herein by reference.
- C. The Declarant desires to amend the Declaration as set forth in this First Amendment to further define and clarify Owner's rights in the Project.
- D. Unless otherwise set forth herein, the capitalized terms shall have their same meanings and definitions as stated in the Declaration.
- E. Pursuant to Article 14, Section 14.2 of the Declaration, the undersigned hereby certifies that this First Amendment was approved, executed, and acknowledged by Declarant during the Declarant Control Period pursuant to Declarant's unilateral amendment right.

## **AMENDMENT**

NOW, THEREFORE, in consideration of the foregoing Recitals, the Declarant hereby executes this First Amendment, which shall be effective as of its recording date with the Utah County Recorder.

- (1) <u>Amendment No. 1</u>. Section 4.13 shall be deleted in its entirety and replaced by the following:
  - 4.13. Reinvestment Fee. The Board shall have the right to establish (but shall not be required to establish) a Reinvestment Fee in accordance with this Section and Utah Code § 57-1-46. If established, the following terms and conditions shall govern Reinvestment Fees:

Other than Declarant (or its affiliates or successors) or Holmes Homes, Inc. (or its

affiliates or successors), upon the occurrence of any sale, transfer, or conveyance of any Lot as reflected in the office of the County recorder, regardless of whether it is pursuant to the a sale of the Lot or not (as applicable, a "Transfer"), the par ty receiving title to the Lot (the "Transferee") shall pay to the Association a Reinvestment Fee in an amount to be established by the Board in the Rules, provided that in no event shall the Reinvestment Fee exceed the maximum rate permitted by law. The Association shall not levy or collect a Reinvestment Fee for any Transfer exempted by Utah Code § 57-1-46. The Reinvestment Fee shall be due and payable by the Transferee to the Association at the time of the Transfer giving rise to the payment of such Reinvestment Fee and shall be treated as an Individual Assessment for collection purposes.

All transfers of Lots to (a) Declarant (or its affiliates or successors), or (b) Holmes Homes, Inc. (or its affiliates or successors), shall be exempt from a Reinvestment Fee. The Declarant shall have the sole discretion to determine whether such Transferee is a related entity and if a Reinvestment Fee applies.

- **Conflicts.** All provisions of the Declaration not specifically amended in this First Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or any prior amendments, the provisions of this document shall in all respects govern and control.
- (3) <u>Incorporation and Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
