 - (iii) A Supplement to the Declaration of Protective Covenants, Conditions and Restrictions for Farmington Ranches Phase 1 Adding Farmington Ranches Subdivision Phase 2, dated August 7, 2001 (as amended and/or supplemented, the "Declaration"), which was recorded August 7, 2001, as entry No. 1680180, in Book 2861 at Page 571, of the officials of Davis County, State of Utah (the "Declaration").
 - (iv) First Amendment to the Declaration of Protective Covenants, Conditions and Restrictions for Farmington Ranches Phase 1, dated October 25, 2001 (as amended and/or supplemented, the "Declaration"), which was recorded October 29, 2001, as entry No. 1698935, in Book 2914 at Page 348, of the officials of Davis County, State of Utah (the "Declaration").
 - B. Declarant desires to amend the Declaration in certain respects.

The existing sentence in Paragraph 8.3 of the Declaration that reads: "Pitched roofs shall be at least 4/12 pitch and no greater than 10/12" shall be replaced with an entirely new sentence that reads: "Pitched roofs shall be at least 4/12 pitch and no greater than 12/12".

- 2. In all other respects, the Declaration, Supplements, Amendments and Plat are ratified and affirmed.
- 3. The vote required for amendment of the Declaration of Covenants has occurred, in accordance with the Amendments portion of the Declaration.
