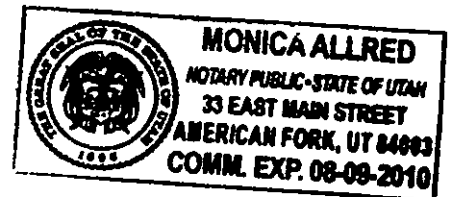

A part of the Northwest Quarter of Section 16, Township 5 South, Range 1 East, Salt Lake Base and Meridian, U.S. Survey in the City of Lehi, Utah County, Utah:
