POLE LINE LICENSE AGREEMENT

This Pole Line License Agreement made this 29th day of July, 1965, by NATIONAL SECURITIES, INC., a Colorado Corporation, qualified to do business in the State of Utah, and SECURITY TITLE COMPANY, A Utah Corporation, acting herein jointly as Licensor in favor of UTAH POWER AND LIGHT COMPANY, as Licensee, as follows:

For and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the Licensor hereby grants to the Licensee, its successors and assigns, a revocable license for the erection, maintenance, operation, and repair of an electric transmission pole line consisting of one guy anchor and four poles with the necessary attachments affixed thereto for the support of such circuits to be erected and maintained over, along and across the premises of the Licensor in Salt Lake County, State of Utah, and along a center line particularly described as follows:

Beginning at a point on the North boundary fence of the Licensor's land, which point is 1320 feet North and 505 feet West from the South Quarter Corner of Section 14, Township 3 South, Range 1 East, Salt Lake Base and Meridian, and from said point running thence South 23°23' West 1.5 feet; thence South 33°17' East 1550 feet, more or less, to the South line of the property of the Licensor and located in the Southeast Quarter of the Southwest Quarter, and the Southwest Quarter of the Southeast Quarter of said Section 14.

Included within the scope of the license hereby granted is the right from time to time to cut or trim trees, vines, or branches on the premises which interfere with the wires, cables, or attachments of the Licensee upon condition that all such cutting or trimming shall be done in a proper manner so as to cause no permanent injury to any such trees or branches.

This License is granted subject to the express condition of revocation by the Licensor upon written notice to the Licensee, upon receipt of which such poles, wires, cables or other attachments shall be removed or relocated consistent with such written instruction.

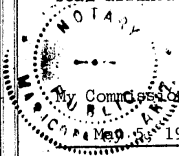
