QUIT - CLAIM DEED

THE STATE OF UTAH, BY AND THROUGH the State Land Board, by its Director, Grantor, hereby Quit-Claims to H. R. FISHER of Salt Lake City, Utah, and to his successors and assigns (having succeeded to various portions of the within described property by conveyance from said H. R. FISHER) Grantees, for the sum of TEN & NO/100s (\$10.00) and other good and valuable considerations, all of its right, title and interest in and to all sand and gravel located within the following described tract of land in Salt Lake County, State of Utah, to-wit:

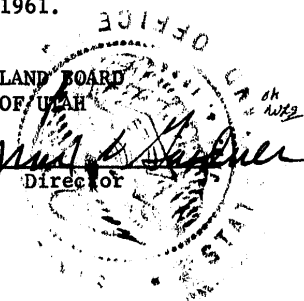
The South Half (S $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$); the South Half (S $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) and the Northwest Quarter (NW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirteen (13); the Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Fourteen (14), except Three and 34/100 (3.34) acres conveyed to Dry Creek Reservoir and Irrigation Company; the South Half (S $\frac{1}{2}$) of the South Half (S $\frac{1}{2}$) of Section Fourteen (14); the South Half (S $\frac{1}{2}$) of the South Half (S $\frac{1}{2}$) of Section 15; the Northeast Quarter (NE $\frac{1}{4}$) and the East Half (E $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Twenty-two (22); the Northwest Quarter (NW $\frac{1}{4}$), and the Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter of Section Twenty-three (23), all in Township Three (3) South, Range One (1) East, Salt Lake Meridian.

This conveyance is made and executed for the express purpose of releasing to said grantee any rights to sand or gravel as reserved to the State of Utah by that certain Quit-Claim Deed dated October 27, 1955, and recorded October 28, 1955 in Book "1253" at page 316 as entry No. 1453527 of the records of the Recorder of Salt Lake County, Utah.


