for and in consideration of the sum of \$1.00 and other valuable consideration, the receit whereof is hereby acknowledged, hereby grants to UTAH POWER & LIGHT COTTANY, a corporation, Grantee, its successors and assigns, an easement and right of way to construct, reconstruct, operate, maintain and repair over, under and across property of the Grantor in Salt Lake County, State of Utah, an underground duct line, along a line described as follows:

A 10 foot wide utility Easement, the centerline of which begins at a point which is S 54 21'12" W 5 feet from a utility pole, said point also being South 3966.77 feet and East 1325.65 feet and S 89 47' E 300.29 feet and North 17.80 feet from the North Quarter Corner of Section 14, Township 3 South, Range 1 East, Salt Lake Base and Meridian and running thence N 54 21'12" E 149.68 feet, thence N 70 27'24" E 59.89 feet; thence N 59 49'24" E 60.98 feet; thence N 49 16'36" W 90.17 feet; thence N 15 10'36" W 131.41 feet; thence N 35 59'18" W 57.53 feet; thence N 30 20 W 60.00 feet; thence N 40 19 E 140.00 feet; thence N 22 18' E 43.0 feet to a point which is N 22 18' E 5.0 feet from a utility pole said point being the Northerly end of said Easement.

ALSO, a 10 foot wide utility easement the center line which begins at a point which is due South 3,713.96 feet and due East 1,777.71 feet from the North quarter corner of said Section 14, and running thence N 74°49'E 50.4 feet more or less to the grantors Easterly property line.
