ORDER OF EXCLUSION

Civil No. 5100-92340

A. On April 30, 1990, the Salt Lake County Water Conservancy District, "District", filed a petition with the Court for a judicial determination that the proceedings and actions of the District in authorizing the exclusion of lands from the District are lawful and valid and for an order excluding lands from the District.

B. Pursuant to U.C.A. § 73-9-36, notice of the filing of the petition and of the hearing thereon on June 8, 1990 was published once a week for five consecutive weeks in the Salt Lake Tribune and the Deseret News and said notice was also posted in the principal office of the District at least thirty days prior to said hearing. In addition, the notice of the hearing was delivered to each of the District's customer agencies.

C. This matter then having come regularly before the Court on this 8th day of June, 1990, the Court, upon hearing and review of the exhibits presented and received and the allegations of the petition, reviewed the issues as follows:

- (i) A letter dated June 6, 1990 from Mr. Roland Robison, Regional Director of the Upper Colorado Regional Office, Bureau of Reclamation, United States Department of the Interior, acting on behalf of the Secretary of the Interior, (a) assenting to the exclusion as ordered by the District to the extent required by any applicable provisions of the Water Conservancy Act, and (b) consenting to the adoption of a supplemental resolution by the Board of Directors of the District amending the master bond resolution of the District to provide for the exclusion as ordered by the District.
- (ii) A letter of consent from Bond Investors Guaranty dated May 7, 1990, consenting to the adoption of a

supplemental resolution by the Board of Directors of the District amending the master bond resolution of the District to provide for the exclusion as ordered by the District.

- (iii) A letter of consent from Marine Midland Bank, N.A., dated May 23, 1990, consenting to the adoption of a supplemental resolution by the Board of Directors of the District amending the master bond resolution of the District to provide for the exclusion as ordered by the District.
- (iv) A Memorandum in Support of Petition filed by the District.
- (v) The exhibits attached to the petition and those presented at the hearing along with those relevant materials submitted or verified in this proceeding.

There were no protests, objections or other adverse claims to the Order presented to the Court within the prescribed period of time under U.C.A. § 73-9-36.

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. The action of the Board of Directors of the District in adopting a Resolution and Order of Exclusion of Sandy lands from the Salt Lake County Water Conservancy District dated April 27, 1990 is lawful and valid.

2. The lands hereby excluded from the District shall remain subject to all taxes levied by the District in 1990. The lands hereby excluded shall also remain subject to levy of taxes for the payment of operation and maintenance costs of the District to the extent necessary to prevent or cure a default in the payment of principal of or interest on the \$33,340,000 Water Conservancy Revenue Refunding Bonds, Series 1987, (referred to in the District Order as Series 1987 Conservancy Bonds) issued by the District on or about March 3, 1987 and on all other bonded or contractual obligations of the District incurred by the District prior to August 24, 1989.

3. The lands hereby excluded shall not be liable for any additional taxes or additional bonded indebtedness which may hereinafter be incurred by Salt Lake County Water Conservancy District or so levied by Salt Lake County Water Conservancy District except as specified in paragraph 2 hereinabove.

- 4. As a condition of this Order, Sandy City has agreed and is required to pay the sum of \$1,272,000 on or before August 15, 1990 together with interest as specified in the Resolution and Order of Exclusion issued by the District on April 27, 1990.
- 5. As a condition of this Order, Sandy City has agreed and is required to pay any and all legal expenses related

to legal services performed by the law firm of Clyde, Pratt & Snow and the law firm of Chapman and Cutler which relate to the exclusion proceedings.

6. Sandy City has heretofore had two representatives on the Board of Directors of the District. With Sandy's withdrawal, those two directorships are eliminated, thus reducing by two the total number of directors of the District, and it is so ORDERED.
