PROTECTIVE COVERANTS

TO CHUR IT MAY JONG MY:

We, the owners of the following described property:

"all lots in Janyon aim admittion, Amended and Extended, except lot  $33.7^{\circ}$ 

in consideration of the promises and as part of the general plan for improvement of said property, do herety declare the property hereint over dead local subject to the restrictions and covenants herein recited.

- 1. There coverants are to run with the land and shall be binding on all persons claiming under them from data hereof until January 1, 1973, at which time said coverants shall be automatically extended for successive periods of ten years unless by vote of a mejority of the then owners of the lots it is agreed to chance said coverants in choic or in part.
- 2. If the parties hereto, or any of them or their heirs or assigns, shall violate or attempt to violate any of the covenants herein, it shall be lowful for any other person or persons owning any real presents situated on the slove-described tract to prosecute any propositives at low or in equity prainst the person or persons violating or attempting to violate any such covenants and either to present his or them from so doing or to recover done as or other case for such violation.
- 3. Invaligation of any one of these covenants by judgment or court order shall in no wisc affect any of the other provisions which shall reason in full force and effect.
- 4. All some rescriced lots in the arove described subcivision, except one 32, 34, and 55, shell be known and described as residential lots. As structures shell be erected, altered, placed or remaitted to reason on any residential building plot other man one betweeked sin le-family dwelling not to exceed two stories in height and a private garage for not more than two cars. Lots 32, 34, and 35, may to used for the purpose of conducting retail cusinesses, including sarvice stations, barber shops, stores, and claces of entertainment and recruation.
- 5. To building shall be erected, placed or altered on any building plot in the slove-described property until the building clans, specifications, and plot plan showing the location of such building have deen approved in writing as to conformity and harmony of enternal decign with existing structures in the said property, and as to location of the building with respect to topography and finished grown elevation, by a committee composed of M. Kenneth white, Ada marke white, and alton C. Melville, or by a representative designated by a majority of the members of said committee. In the event of death or resignation of any member of said committee, the remaining member, or members, shall have full authority to approve or disapprove such design and location within thirty days after said clans and specifications have been submitted to it or, in any event, if no suit to enjoin the erection of such building or the making of such alterations has been commenced prior to the completion thereof, such approval will not be required and this covenant will be exceeded to have been fully complied with. Neither the members of such committee, nor its designated representative, small ce entitled to any compensation for services performed pursuant to this covenant. The powers and duties of such committee, and of its designated regresentative, shall cease on or after January 1, 1955. Thereafter, the approval described in this covenant shall not be required unless, prior to said date and effective thereon, a written instrument shall be executed by the then

record owners of a majority of the lots cove described and duly recorded appointing a representative, or representative, who shall thereafter exercise the same powers reviously exercised by said committee.

- 5. No building shall be located on any residential building lot described above nearer than twenty feet to the front lot line, excluding porches, cornices, groutines, chimneys, and purely ornamental projections. No building except a detached garage or other outbuilding located seventy feet or fore from the front lot line shall be located nearer than tive frot to any side lot line. No residence shall be created on any of the above lots further than forty feet from the front lot line.
- 7. No residential accepture shell be breated or placed on any of the serve-rescribed indictive slots, which riot has an area of less than fitted senses feet or a which of less than fifty feet at the front bulkelin recessful line.
- Carried on upon any lot non-sell anything to lone traceon which may be or locume on annoyated or make upon to the neith origod.
- 9. No preiser, because, that, much, purses, item, or other outsuitains errobed in the sais or at siell to any time be used to a resistance that search a community, nor shall any structure of a passoring solution of a resistance temporarily or sammently, nor shall try structure of a passoring character be take as a resistance.
- 10. No swelling coating less than 3,000.00 shall be permitted on any of the acceptance dots in soid subsidion. The ground floor area of the tain structure, exclusive of one-story oren porcies and parameter, could be not less than 750 square feet in the case of a one-story structure, nor less than 700 square feet in the case of a one-stary structure, nor less than 700 square feet in the case of a one-stary structure.
