hereby Quit-Claim to Salt Lake County, grantee, for the sum of

ONE AND No/100 Dollars, a perpetual right-of-way

over and across the following described tract of land in Salt Lake County, State of Utah:

= Right of Way for highway known as 3900 South Street, Project S-296-(2) across the grantors land in the SW 1/4 of Section 35, T1S, R1E, S.L.B.&M.; said right of way is contained within a parcel of land 40 feet wide on the South side of the centerline of said project. Said centerline is described as follows:

Beginning at the intersection of the West boundary line of said grantor's land and said centerline of survey at Engineer's Station 207+55.21, said centerline being on the Salt Lake County monument line of 3900 South Street, which point is S 89°54' E 271.32 feet and S 88° 46' E 155.21 feet from the Salt Lake County monument at the intersection of 2700 East Street and 3900 South Street; thence S 88° 46' E 214.5 feet to the intersection of said centerline at Engineer's Station 209+69.71 and the East boundary line of grantor's land as shown on the official map of said project on file in the office of the Salt Lake County Surveyor.

The above described parcel of land contains 0.197 acres less .143 acres now it being the intention of said party of the first part to donate said right-of-way to said Salt Lake County for the use of the public as a highway.

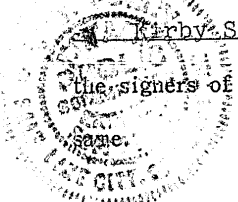

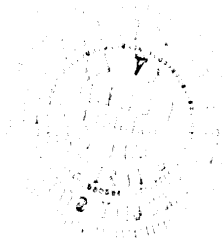
