Right of way Clearfield Service line

Woods Cross Canning Company, Grantor, of Woods Cross, State of Utah, hereby conveys and Warrants to Wasatch Gas Company, a Utah corporation, grantees of Salt Lake City, State of Utah, its heirs, successors and assigns, for the sum of one Dollar, the right of way to lay, maintain, operate and remove pipe lines, gates, gate boxes, etc, with the right of ingress and egress to and from said right of way, over and through the following described tract of land in Township 4 N, Range 2 W, in the County of Davis, State of Utah, bounded and described as follows:

That part of the north-west quarter of the south-west quarter of section 1 now owned by the Woods Cross Canning Company. Also permission to locate and maintain a field regulator in the present meter house of the Woods Cross Canning Company at Clearfield, Utah.

The said grantor, to fully use and enjoy the said premises except for the purpose hereinbefore granted to the said grantee, which hereby agrees to pay damages which may arise to crops or fences from the laying, erecting, maintaining, operating or removing of said pipe lines, gates, gate boxes, etc., said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof to be appointed by the said grantors their heirs or assigns, one by the said grantee, its heirs successors or assigns, and the third by the two so appointed as aforesaid. Should more than one pipe line be laid under this grant at any time, a like consideration shall be paid for each line so laid, in addition to the damages above provided for.
