SEWER LINE AGREEMENT

Said sewer line will run approximately 125 to 135 lineal feet from south to north,*just inside the west boundary line of the Hawley property, which will accomodate the digging machine space requirement and the Salt Lake City Corporation sewer survey. (*24" or less is considered sufficient)

It is understood by P. P. P., Incorporated that the expense of the proposed sewer will be that of P. P. P., Incorporated, and that the Hawley property will be left in the same condition as before.




