This easement is executed for no monetary consideration and for the general improvement to the grantors' lands which will result from the installation of the storm drain.

It is expressly understood and agreed that Ogden City after laying the said storm drain, shall cause the excavation to be backfilled, remove from said premises and right-of-way, all excess dirt and overburden, leaving the said premises in as nearly the original condition as practicable, including restoring the surface of the easement.

And, it is further understood and agreed that the said Grantee, Ogden City, shall have the right of ingress and egress to and from said perpetual easement and right-of-way, at any and all times, for the purpose of inspecting, maintaining or repairing said storm drain.

The Grantee by the acceptance hereof agrees to relocate the storm drain herein described to another feasible location on grantors' lands should grantors or any of them require the same for their own use.

Each of the grantors hereby grant the easement above described on the land owned by said grantor and makes no attempt to grant an easement over any land other than that owned by said grantor.
