## ADDENDUM No. 1 TO RESTRICTIONS AND EASEMENTS AGREEMENT

This ADDENDUM NO. 1 to that certain Restrictions and Easements Agreement identified in Recital A is dated this 20th day of August, 2003, and is entered into by and between Smith's Food & Drug Centers, Inc., a Delaware corporation ("Smith's"), and H.V. Commercial, L.L.C., a Utah limited liability company ("Developer").

- A. Smith's and Developer entered into that certain Restrictions and Easements Agreement, dated February 13, 2003, and recorded in the office of the Salt Lake County Recorder on February 26, 2003, as Entry No. 8544976 in Book 8745 at Page 1714 ("REA") with regard to the following real property:
  - Lots 2, 3, 4, and 5, Herriman Town Center, a Commercial Subdivision, according to the official plat thereof recorded in the office of the Salt Lake County Recorder.
  - B. Smith's and Developer desire to amend Sections 1.e. and 2.d.(iii) of the REA.

NOW, THEREFORE, Smith's and Developer amend the REA as follows:

## 1. Section 1.e.

The Floor Area on Pad C is hereby expanded by approximately 1,000 square feet, from 5,000 square feet (as shown by the dotted line on Exhibit "A" attached to the REA) to a new total pad building size of 6,000 square feet. The parties further acknowledge and agree that said expansion shall not reduce the number of available parking spaces below that number required by applicable governmental authorities. (See Exhibit "A" attached hereto.)

## 2. Section 2.d.(iii).

Smith's and Developer hereby agree to allow a small women's only fitness center, occupying approximately 5,432 square feet, to be operated in Space B-2 (see Exhibit "A" attached hereto), and hereby delete the reference in said section to a "health spa (more than 2,000 square feet in floor area and not to exclude small additional day spa services to a full service tanning or beauty salon)" as a restriction on use.

3. To the extent that any terms of this Addendum modify or conflict with any provisions of the REA, then these terms control. All other terms of the REA not modified herein shall remain unchanged and in full force and effect.

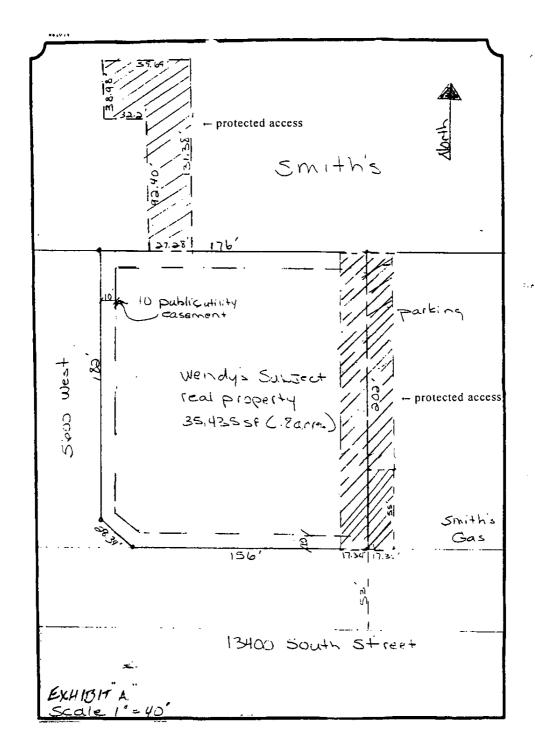
