A strip of land in the Southeast Quarter of the Northwest Quarter (SDINW) and in the Northeast Quarter of the Southwest Quarter (NELSW) of Section Twenty-six (26), Township Three (3) North, Range One (1) West, Salt Lake Base and Meridian, Thirty-one (31) feet wide and included between two lines extended to the property lines and everywhere (istant Eighteen (18) feet on the right or West side and Thirteen (13) feet on the left or East side of that portion of the following described centerline of what is known as the West Farmington Lateral 1.3L-0.5R from Station 54+73.0 to Station 62+97.5 measured at right angles thereto; said centerline is more particularly described as follows:
