


**Amendments to Legacy Industrial Park Final Plat, recorded December 15,
1998 as Entry No. 7189827 in Book 9812p at Page 0344,
records of Salt Lake County, Utah.**

The following typing errors were found:

1. The bearing and distance between the South Quarter corner and the Southeast Corner of Section 11, shown on the said plat as N 89°54'44" W, 2666.87' should read N 89°55'44" W, 2666.83'.
2. The bearing between the Center of and South Quarter Corner of Section 11, shown as S 00°10'12" W on said plat should be removed and the bearing and distance will remain S 00°10'17" W, 2648.38'.
3. Both distances shown between the North Quarter corner and the Center of Section 11 should be removed and read one distance of 2649.38'.
4. The bearing and distance shown between the North Quarter Corner and the Northeast Corner of Section 11 shown as S 89°54'08" East, 2653.78' should be removed and the bearing and distance of S 89°53'59" E, 2653.84' should remain as the measured distance.
5. The distance shown between the Northeast Corner and the East Quarter Corner of Section 11 shown as 2648.42' should be removed and the distance shown as 2648.77' should remain.
