   Condominium, recorded in the office of the Salt Lake County Recorder on May 2, 2014 as Entry
   No. 11843252, Book 10228, beginning at Page No. 1055.
- 2. Shortly after the Declaration was recorded, it was discovered that Exhibit A to the Declaration, which is a legal description of the Presidential Villas Condominium, contained scriveners' errors, specifically, various coordinates contained the letter "1" where the degree symbol should be. The recorded Exhibit A, found in Book 10228 on Page No. 1104, provides the following property description:
