# SECOND AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR SADDLEBROOK CONDOMINIUMS

This Second Amendment to the Declaration of Condominium for Saddlebrook Condominiums (the "Second Amendment") is executed and adopted by Edge Saddlebrook, LLC (the "Declarant").

#### RECITALS

- A. The Declaration of Condominium for Saddlebrook Condominiums was recorded on February 2, 2018 as Entry No. 12709696 in the office of the Salt Lake County Recorder (hereinafter the "Declaration").
- B. The First Amendment to the Declaration of Condominium for Saddlebrook Condominiums was recorded on June 29, 2018 as Entry No. 12801802 in the office of the Salt Lake County Recorder (hereinafter the "Declaration").
- C. This Second Amendment affects the real property located in Salt Lake County, State of Utah, described with particularity on Exhibit A, which exhibit is attached hereto and incorporated herein by reference.
- D. The Declarant desires to amend the Declaration as set forth in this Second Amendment to provide certain protections and rights to Mortgagees.
- E. Unless otherwise set forth herein, the capitalized terms shall have their same meanings and definitions as stated in the Declaration.
- F. Pursuant to Article 15, Section 15.1 of the Declaration, the Declarant has the sole authority to amend the Declaration so long as Declarant owns one or more Units in the Project.
- G. As of the date of the recording of this Second Amendment, Declarant is the owner of more than one Unit in the Project.

## **AMENDMENTS**

NOW, THEREFORE, in consideration of the foregoing Recitals, the Declarant hereby executes this Second Amendment, which shall be effective as of its recording date with the Salt Lake County Recorder's office.

- (1) <u>Amendment No. 1</u>. The following Section 13.6 shall be added to Article 13 of the Declaration as follows:
- 13.6. **Notifications.** Lenders and their insurers or guarantors, upon written request to the Association, shall have the right to timely written notice of:
  - (a) any condemnation or casualty loss that affects a material portion of the Project or the Unit securing the Lender's mortgage;
  - (b) any 60-day delinquency in the payment of assessments or other charges owed by the Unit Owner of any Unit on which the Lender hold a mortgage;
  - (c) a lapse, cancellation, or material modification of any insurance policy maintained by the Association; and
  - (d) any proposed action that requires the consent of a specified percentage of mortgagees.
- (2) <u>Amendment No. 2</u>. The following Section 13.7 shall be added to Article 13 of the Declaration as follows:

## 13.7. Lender Approval.

- (a) Declaration amendments of a material adverse nature to Lenders must be consented to by Lenders that represent at least 51% of the total Allocated Interest of all Units.
- (b) Any termination of the Project after substantial destruction or condemnation must be consented to by Lenders that represent at least 51% of the Allocated Interest of all Units.
- (c) Unless otherwise required or permitted under Utah law, Lender consent may be implied when a Lender fails to submit a response to any written proposal for an amendment or termination within 60 days after it receives notice of the proposal, provided the notice was delivered by certified or registered mail, with a return receipt requested.
- (d) The term "material adverse nature" shall mean a modification that directly and materially reduces a specific and identified Lender right set forth in the Declaration. Amendments that simply modify certain language or terminology applicable to Lenders, but do not materially reduce Lender rights, shall not require the consent of Lenders.
- (3) <u>Conflicts</u>. All remaining provisions of the Declaration and any prior amendments not specifically amended in this First Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or any prior amendments, the provisions of this document shall in all respects govern and control.
- (4) <u>Incorporation and Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms,

definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
