This agreement made and entered into by the undersigned lessor, (the "Lessor") and by Reagan Outdoor Advertising, (the "Lessoe"). Both lessor and lessoe acknowledge the receipt and sufficiency of good and valuable consideration and agree as follows:

The leasor does hereby grant and convey to the leasor and its assigns and successors, the exclusive right to use the following described property for the purpose of erecting and maintaining thereon outdoor advertising structures including succ necessary devices, structures, connections, supports and appurtenances as may be desired by leasee for a term of ten years commencing on or before day of 1943 at option of leasee, upon the following described land, together with ingress and egress to and upon the same, located in the country of 1947 and 1949.

State of Utah and more particularly therefore as follows: Lessee shall pay lessor the amount of \$25000 annually, payable (monthly, quarterly, semi-annually); however, prior to construction and obtaining permits by lessee the rental shall be Five Dollars.

This lease shall continue on the same terms and conditions for a like successive period; thereafter, this lease shall continue in full force on the same terms and conditions for a like successive period or periods, unless lessor delivers to lease notice of termination within ninety days of the end of said term.

ninety days of the end of said term.

It is further expressly agreed that lessee may terminate this lease by giving written notice and paying a penalty of one year's rent at any time within thirty days prior to the end of any twelve month period subsequent to the commencement date of this lease. Provided further, if the said space becomes obstructed so as to lessen the advertising value of any of issues is sign erected on said premises, or if tradic is diverted or reduced, or if the use of any night signs as prevented or felfflicied by law, of if for any reason a building permit for erection or modifications is refused this lease may, as the option of lessee, be terminated or the rest reduced to five Dollars while said conditions exists and in such event lessor shall refund prorate any prepaid restal for the wavespired term. Lessor agrees that no such obstruction inspire, as the same is within lessor's control will be permitted or allowed. Lessor authorized lesses to trim and cut whatever trees, bushes, brush, as it deems necessary for unobstructed view of its advertising display.

All advertising signs placed-upon the described premises are to remain the property of lessee and may be removed by lessee at any time. If lessee is prevented by law, or government or military order, or other causes beyond lessee's control, from illuminating its signs, the lessee may reduce the rental provided herein by one-half with such reduced rental to remain in effect so long as such condition continues to exist.

Lessor warrants the title of said leasehold for the term herein mentioned. In the event this lesse is not renewed or cancelled, lessor agrees that he will not for a period of five years subsequent to the date of termination, release said premises to any other advertiser other than lesser for advertising purposes. In the event lessor shall decide during the term of this lease to sell the premises described herein, lessor shall give written notice to Reagan of the terms and price offered by a third party. Reagan shall be entitled for thirty (30) days to acquire the premises on the terms and conditions in said notice. If Reagan does not expense said right of purchase, the lessor shall not sell the premises on other terms for six (6) months. Thereafter, Reagan shall have the same right as to any subsequent offer to purchase. It is expressly understood that neither the lessor nor lessee is bound by any stipulations, representations, or agreements not printed or written in this lesse.

This agreement shall inure to the benefit of and shall be binding upon the heirs, per-sonal representatives, successors, and assigns of the parties hereto. & July
