POLE LINE EASEMENT

1. Hugh L. Barnes and Araminta B. Barnes his wife, Grantor's of Weber County,
Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in
interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable considera-
tion, a perpetual easement and right of way for the erection and continued maintenance, repair,
alteration, and replacement of the electric transmission, distribution and telephone circuits
of the Grantee, and 2 guy anchors and 4 poles, with the necessary guys, stubs, crossarms and
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected
and maintained upon and across the premises of the Grantors, in Morgan County, Utah, along a
line described as follows:

Beginning on grantor's land at a point 230 feet south and 710 feet west from
the east quarter corner of Section 7, T. 4 N., R. 2 E., S.L.B. & M., thence running N. 69°31'
E. 979 feet on said land and being in the NE 1/4 of the SE 1/4, the SE 1/4 of the NE 1/4 of said Section
7 and the SW 1/4 of the NW 1/4 of Section 8, Township and Range aforesaid.

Excepting therefrom that part of line on or over State Highway No. 5

Together with all rights of ingress and egress necessary or convenient for
the full and completed use, occupation and enjoyment of the easement hereby granted, and all
rights and privileges incident thereto, including the right to cut and remove timber, trees,
brush, overhanging branches and other obstructions which may injure or interfere with the
Grantee's use, occupation or enjoyment of this easement.
