ROBINS, his wife, hereinafter referred to as "Grantors", for and in consideration of the sum of TWO HUNDRED FIFTY DOLLARS (\$250.00), to them in hand paid, receipt whereof is hereby acknowledged, does hereby for themselves, their heirs, successors and assigns, grant unto MOUNTAIN FUEL SUPPLY COMPANY, a corporation of the State of Utah, its successors and assigns, hereinafter referred to as "Grantee", the right and privelege to use as a roadway a strip of land for the transportation of supplies, materials and for use as a driveway for all kinds of vehicles used in the building, operating, maintenance, repairing and removing gas pipe lines and telephone lines, the said roadway crossing the following described land in Morgan County, Utah:

RIGHT OF WAY GRANT AND AGREEMENT

This Right of Way Grant and Agreement made and entered into this 26th day of October, 1950, by and between RACHEL F. CARRIGAN, a widow, of Peterson, Morgan County, Utah, hereinafter referred to as GRANTOR, and MCUNTAIN FUEL SUPPLY COMPANY, a corporation of the State of Utah, hereinafter referred to as GRANTEE,

WITNESSETH:

That the Grantor, in consideration of the sum of TWO HUNDRED FIFTY Dollars (\$250.00), to her in hand paid by Grantee, receipt whereof is hereby acknowledged, and the covenants herein contained, does hereby grant and release to Grantee the right to use a strip of land on which to build a roadway to be used for the transportation of supplies, materials and for use as a driveway for all kinds of vehicles used in the building, operation, maintenance, repairing, and removing pipe lines and telephone lines; the said roadway crossing the following described lands in Morgan County, Utah:

T. 5 N., R. 1 E., S.L.M. Sec. 36, N¹/₂, SE¹/₄

T. 5 N., R. 2 E., S.L.M. Sec. 31, SW4

That the parties hereto hereby covenant with each other, as follows: That the Grantee will use the present roadway wherever practicable, and any new roadway is to be built at a location mutually agreed upon by the Grantor and Grantee, and is to be so located as to give access to the location of the pipe lines and telephone line which cross the above described property.

That the Grantee shall have the full right to use the said roadway as above described, and the full right to install culverts and bridges or use other ways and means to keep water off said roadway. Bridges and/or culverts shall be installed at locations which will give the Grantor herein full use of the irrigation system now being used on the above described land.

That should the Grantor change or improve the irrigation system on the above described land, the Grantee herein agrees to install culverts and/or bridges as necessary to give Grantor full use of the above described land and also full use of the changed or improved irrigation system.
