POLE LINE EASEMENT

AMOS BINGHAM, Grantor, of Morgan County, Utah, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY,
a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other
valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair,
alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee,
and 2 guy anchors and 2 (6-22-61 KEC A/B) poles, with the necessary guys, stubs, crossarms and other attaché
ments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and
across the premises of the Grantor in Morgan County, Utah, along a line described as follows:

Beginning at the east boundary fence on the Grantors' land at a point 600 feet south and 590 feet west, more or
less, from the east one quarter corner of Section 7, T4N., R2E., SLM., thence N. 20° 28' W 762 feet, more or less,
thence N. 17° 00' W. 342 feet, more or less, to the north boundary fence on said land and being in the NE ¼ of
SE ¼ and the SE ¼ of the NE ¼ of said Section 7.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occup-
ation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including
the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure
or interfere with the Grantee's use, occupation or enjoyment of this easement.
