FOR AND IN FULL PAYMENT OF the sum of Seventy Five and no/100 dollars
 (\$ 75.00) the receipt and adequacy of which is hereby acknowledged, Clyde B. Galley &
 Harold J. Galley, and Barbara Gillopie, hereinafter referred to as Grantor (whether one or more),
 does hereby grant to PIPE LINE COMPANY hereinafter referred to as Grantee, its successors and assigns,
 the right to use, install, operate, repair, rebuild, and remove underground communication cables, and such
 other facilities as may from time to time be necessary to the proper installation, operation,
 and maintenance of said cables, together with the right of ingress and egress to and from the same, upon under,
 and across the land, situated in the County of Morgan, State of Utah, to-wit:
 A strip of land situated in the S 1/2 of Section 26, T.5 N., R.1 E.; S.L.B. & M. Said strip
 of land is more particularly shown on Exhibit 'A' attached hereto and made a part hereof.
 Right of land to be returned to as near original condition as is reasonably possible. Grantee shall reimburse
 grantor for land damage caused by the construction and maintenance of said communication
 facility.

Grantee is to have the right to fully use and enjoy the above-described premises except as to the rights
 hereinbefore granted. Grantor agrees not to build, create or construct any obstruction, engineering works, or
 other structure which would interfere with the right of way granted, nor permit same to be done by others.

Grantee hereby agrees to pay all damages which may arise to crops, pasturage, fences, and improvements
 of said Grantor land because of the rights herein granted.

It is understood and acknowledged by the Grantor that the person securing this grant is without
 authority to make any agreement in regard to the subject matter hereof which is not expressed herein and that no
 such agreement shall be binding on the Grantee.

This agreement may be assigned by Grantee, its successors and assigns, in whole or in part. The terms,
 conditions, and covenants hereof shall extend to and be binding upon the heirs, executors, administrators,
 personal representatives, successors, and assigns of the parties hereto.

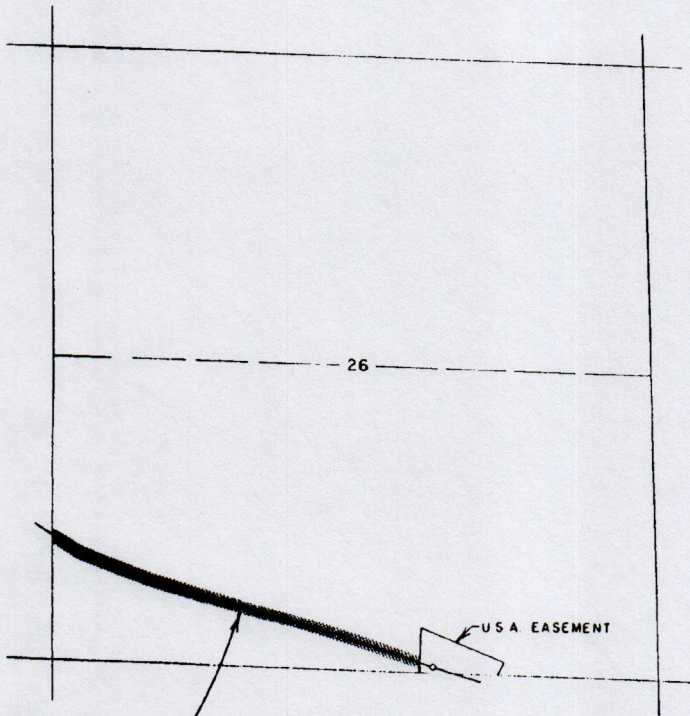
